Residents of South Bass Island may purchase up to 2 electronic Resident Parking Permits per household. Each permit must be associated with one license plate for your car, truck, golf cart, or UTV. Vehicles registered with a Resident Parking Permit will be exempt from paying hourly parking fees, but must abide by all other parking Resident Parking Permits will be valid from May 1 - October 15 of the calendar year in which they are purchased. Permit holders are not guaranteed a parking spot.

To be eligible for a Resident Parking Permit, you must provide:

- A **vehicle registration certificate** for each vehicle; and
- **Proof of residency** in one of the following forms:
 - A copy of your Ohio Driver License showing a residential address on South Bass Island;
 - A copy of a utility bill in your name showing a residential address on South Bass Island;
 - A copy of a tax bill in your name for residential property on South Bass Island; or
 - A copy of your lease for residential property on South Bass Island showing a lease term of at least 90-days.

The Village of Put-in-Bay will be implementing paid parking in the business district in the next few weeks. Paid parking will be enforced on Delaware Ave., Catawba Ave., Hartford Ave., and in the Town Hall Parking Lot. Signs will be posted with instructions for paid parking.

Residents of South Bass Island may purchase up to 2 electronic Resident Parking Permits per household for \$25 each. Each permit must be associated with one license plate for *your* car, truck, golf cart, or UTV. Vehicles registered with a Resident Parking Permit will be exempt from paying hourly parking fees, but must abide by all other parking regulations. Permit holders are not guaranteed a parking spot. Resident Parking Permits will be valid for the 2024 Summer Parking Season (May 1 - October 15, 2024).

To be eligible for a Resident Parking Permit, you must provide a **vehicle registration certificate** for each vehicle, and **proof of residency** in one of the following forms:

- A copy of your Ohio Driver License showing a residential address on South Bass Island;
- A copy of a utility bill in your name showing a residential address on South Bass Island;
- A copy of a tax bill in your name for residential property on South Bass Island; or
- A copy of your lease for residential property on South Bass Island showing a lease term of at least 90-days.

You can apply for an electronic Resident Parking Permit online by scanning the below-provided QR code, or visiting www.tinyurl.com/PIBPERMIT. You will be required to upload proof of residence and you may pay the permit fee by credit card. You may also submit an application, proof of residency, or payment in person at Village Hall, Mon. 9:00AM-12:00PM or Thurs. 10:00AM-12:00PM. You may also drop off an application or proof of residency during regular business hours. Paper applications are available at Village Hall. Once your application is approved, you will receive e-mail confirmation that your license plate(s) is registered and exempt from the hourly parking fee. You will not receive a physical permit.

Once your application is approved, you will receive e-mail confirmation that your license plate(s) is registered and exempt from the hourly parking fee. You will not receive a physical permit. OPERATING IN THE VILLAGE

- Drivers and passengers must abide by *all* Ohio motor vehicle laws
- You must be a licenced driver and have proof of insurance
- Open containers of alcoholic beverages are prohibited, including coolers
- Smoking/vaping cannabis is prohibited
- It is unlawful to exceed the designed seating capacity

PARKING IN THE VILLAGE

- Obey all signs regulating parking
- Obey all Ohio parking laws
- Paid parking is enforced on:
 - Delaware Ave.
 - Catawba Ave.
 - Hartford Ave.
 - Town Hall Parking Lot
- Only golf carts with 4 or fewer seats are allowed to park on Delaware Ave. between Catawba Ave. and Hartford Ave.
- Parking is prohibited in yellow curb zones and red curb zones (fire lanes)
- Overnight parking is prohibited in the paid parking zones (3:00 AM - 6:00 AM)
- Only golf carts and motorcycles may park on Bayview Ave.
- The renter is responsible for all parking citations
